SUMMARY BY: Staff

PROJECT DESCRIPTION / FACTS

- The City was awarded \$1,198,125 for grants to local businesses for reimbursement of costs incurred between March 1, 2020 and December 30, 2020 specific to the public health emergency with respect to COVID-19.
- The City was also awarded \$218,750 to assist with Local Government expenditures specific to the public health emergency with respect to COVID-19.
- As of 12/4/2020 The City has expended \$92,308.24 of the Business Continuity Grant funds to assist local businesses. \$92,691.76 is encumbered leaving a balance of \$1,013,125.00 in the Business Cares Grant Fund. A transfer of \$403,656.53 from the Business Continuity Grant would leave a remaining balance of \$609,468.47.
- AS of 12/4/2020 \$29,016.63 has been spent from the Local Government funds with \$16,379.10 encumbered with a total balance of \$173,754.27 remaining.
- The City has been given preliminary approval by the State for a one time transfer of \$403,656.53 of the Business Continuity Grant funds remaining to the Local Government Grant Funds award to assist residential utility customers who have been impacted by the COVID-19 pandemic and are unable to pay their utility bills.
- The City suspended non-pay disconnects in the early stages of the pandemic and as of today have continued to serve all of our customers regardless of their ability to pay. To date, past due utility accounts total \$402,321.96.
- The transfer of the \$403,656.53 from the Business Cares Grant to the Local Government Grant would assist the City's residential utility customers that have been unable to pay their utility bills for various reasons related to the COVID-19 pandemic.
- With the approaching deadline of December 30, 2020 to expend these funds, staff would like to insure that funding received by the City for local assistance remains in the Community to benefit all affected by the COVID-19 pandemic.
- The transfer would also assist the City in lessening the impact to the utility from customers not being able to pay amounts owed on their utility bills.
- If the Commission decides to approve the CARES ACT AGREEMENT AMENDMENT #1, the deadline for returning the amending resolution to the State is 5:00pm, Friday, December 11, 2020.

PROCUREMENT

 All expenditures must be in accordance with the NM Procurement Code and federal procurement requirements.

FISCAL IMPACTS

- These funds are not considered grants but as other financial assistance. The financial
 assistance are federal funds and subject to the Single Audit Act (City will be subject to
 the single audit rule for FY21).
- Final request for reimbursement must be submitted by January 31, 2021. Final reimbursement will also include a narrative and detail cost report documenting how funds were expended. Record retention for this program is five years after final payment is made. Unexpended funds remain with the state.
