## CITY OF AZTEC OIL & GAS WELL PERMIT PROCESS

---

Oil & Gas Applications are required for the following activities; those not listed do NOT require a permit:

- Drilling new wells
- Plugging and abandoning wells
- Major maintenance work: the addition of a new compressor, the upgrade to a larger horsepower compressor, and/or the addition of a pump jack.

**Step 1** Turn in completed Application and items on Oil & Gas Checklist to the Community Development Department at least 21 days prior to the regularly scheduled City Commission meeting.

**Step 2** The Community Development Department will set up a meeting with all necessary Departments for review of the proposed Oil & Gas Application.

**Step 3** Plan App Review Committee reviews and makes a recommendation to approve or deny the Oil & Gas Application.

**Step 4** The Oil & Gas Application will be placed on the next Commission Meeting agenda as a Business item.

**Step 5** The City Commission meets on the second and fourth Tuesdays of each month at City Hall Commission Room at 6:00 p.m.

- Attendance is required by the applicant or by an authorized representative; applicants wishing to be represented by another party must submit this authorization to the Community Development Department in writing.
- Failure to appear at the meeting may cause the Oil & Gas Application to be postponed until the next regularly scheduled Commission meeting.
- The City Commission will make a determination to Approve or Not Approve the Oil & gas Permit.



## CITY OF AZTEC OIL & GAS WELL REQUIREMENTS

No minor or major oil and gas facility shall be constructed, dug or drilled, plugged or abandoned, nor shall any work in preparation for such facilities/activities be allowed within the boundaries of the municipality until the application and permitting process has been completed and approved by the City Commission. This includes any major maintenance work defined as any maintenance involving the use of a drilling rig, the addition of a new compressor or the upgrade to a larger horsepower compressor, and/or the addition of a pump jack to the well location. The following is required for processing the application:

- \$500.00 fee with completed application form and \$10 fee for an administrative fee;
- A detailed site plan;
- Vicinity map(s);
- Weed and disturbance plan;
- Visual mitigation plan;
- Wildlife mitigation plan (Threatened or Endangered Species Survey);
- Noise mitigation plan;
- Dust mitigation plan;
- Certificate of insurance which certifies that the operator and all persons who may be engaged in the construction of the facility and the drilling or operation of such well are insured to the public for any operation in the sum of five hundred thousand dollars (\$500,000.00) for damages to any one (1) person, and one million dollars (\$1,000,000.00) for damages to more than one (1) person, from any one (1) accident; also, for the sum of five hundred thousand dollars (\$500,000.00) for damages to property.
- One of the following:
  - Surface Damage/Right-of-Way Agreement
  - Verified Statement of Confidentiality
  - Court Order or Judgment
- Evidence of “Reasonable” effort to arrive at an Agreement;
- A copy of the Bureau of Land Management (BLM) or OCD Application Permit Drill (APD) or Sundry Notice 3160-5.
