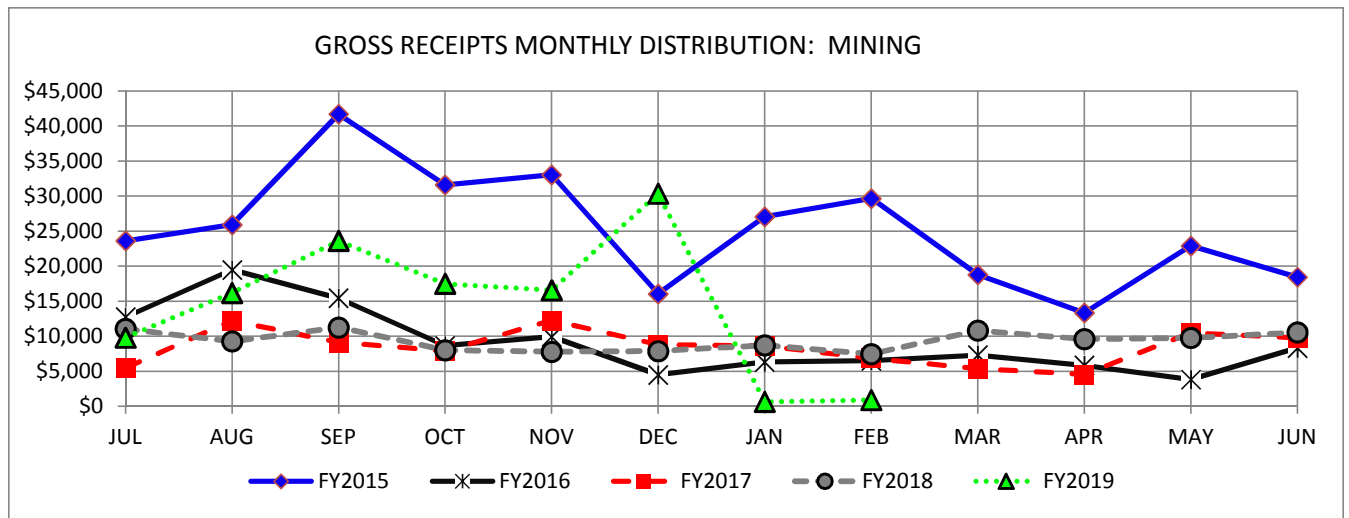
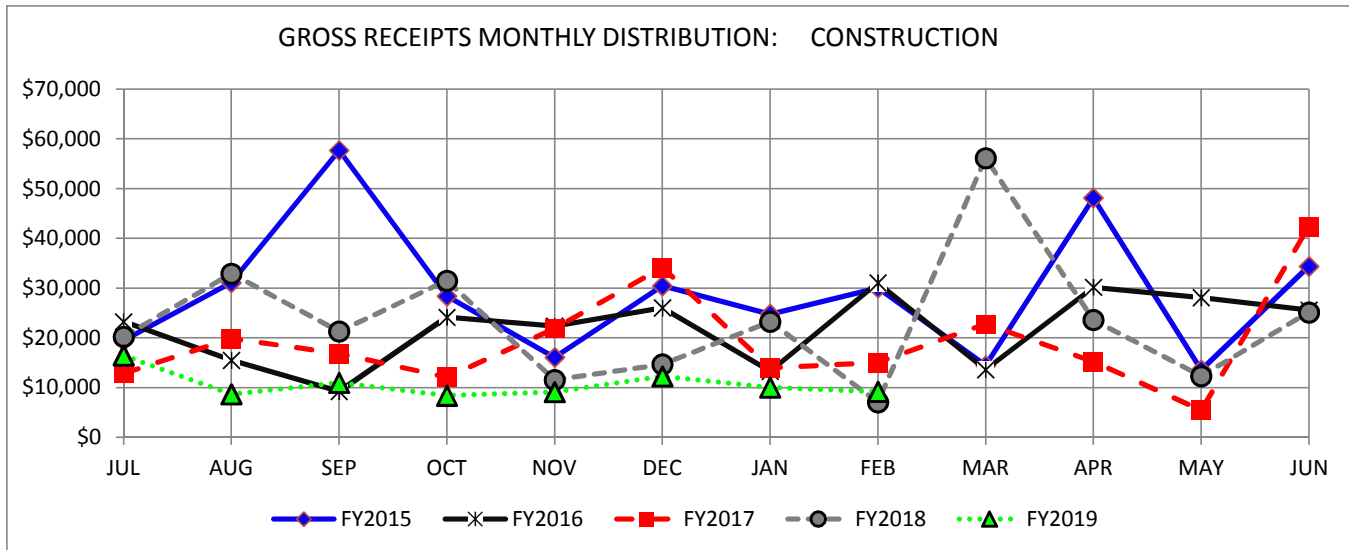
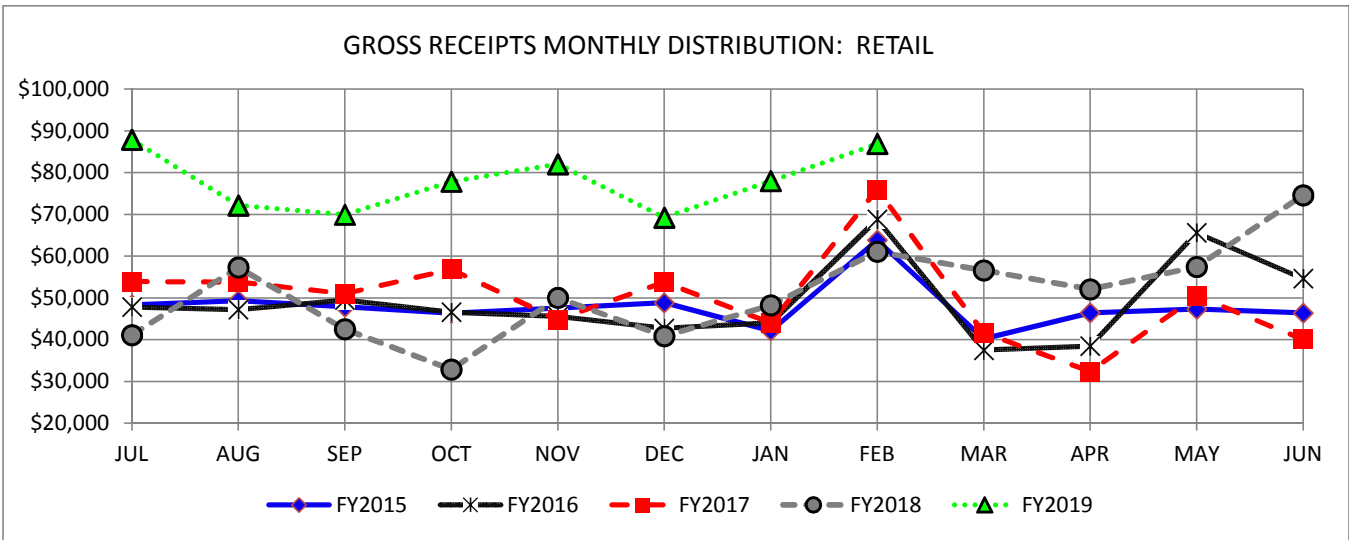
TOTAL GROSS RECEIPTS DISTRIBUTION BY MONTH

May 2018 Distribution includes Food Hold Harmless Correction for March 2018



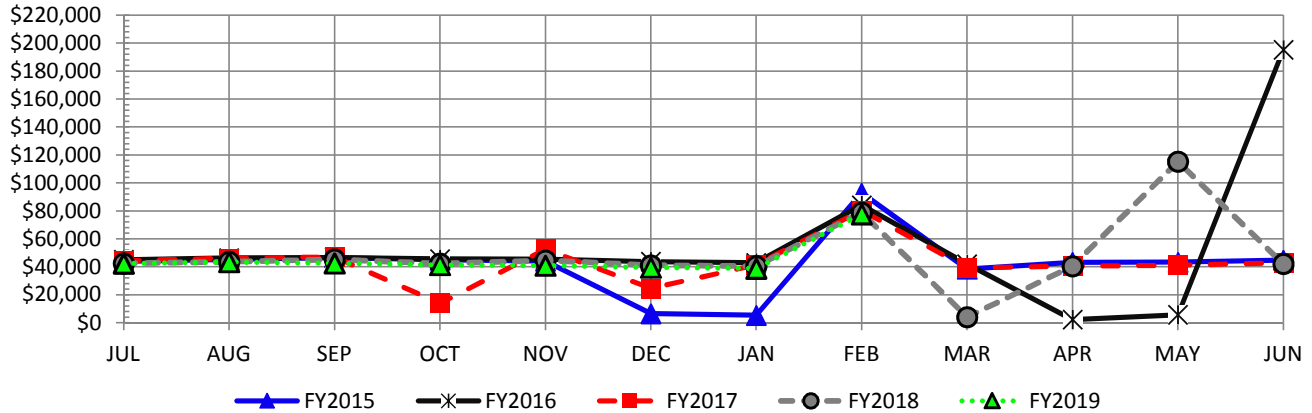

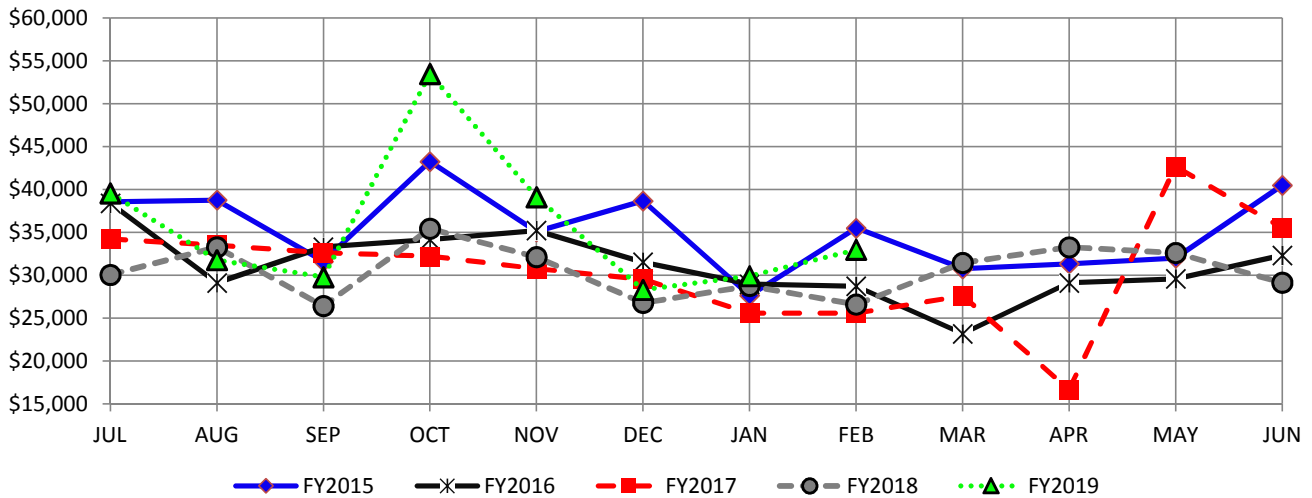

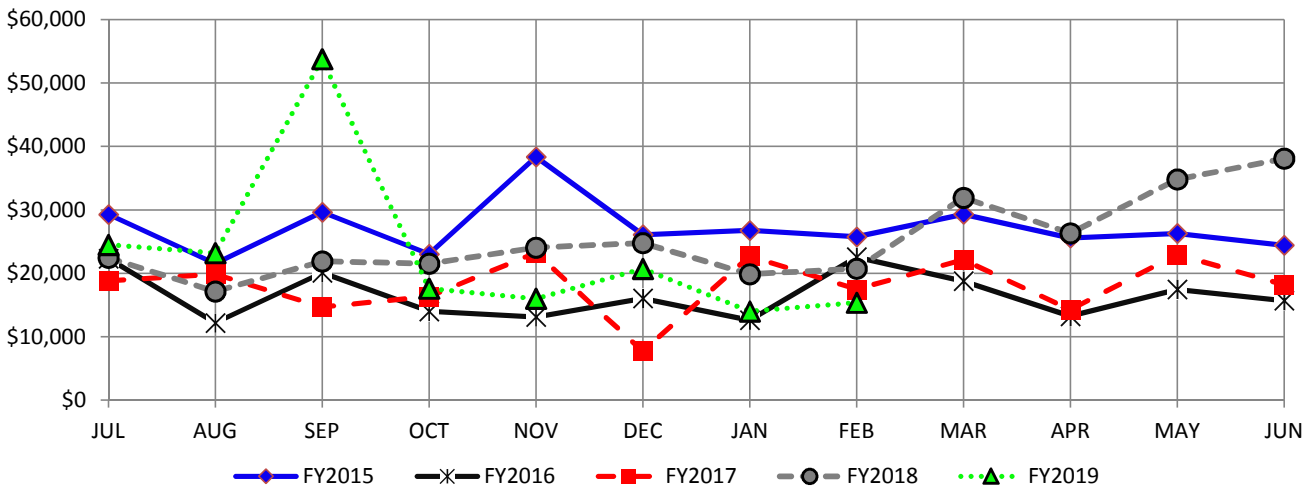
GROSS RECEIPTS MONTHLY DISTRIBUTION: GROCERIES

May 2018 includes correction for March 2018



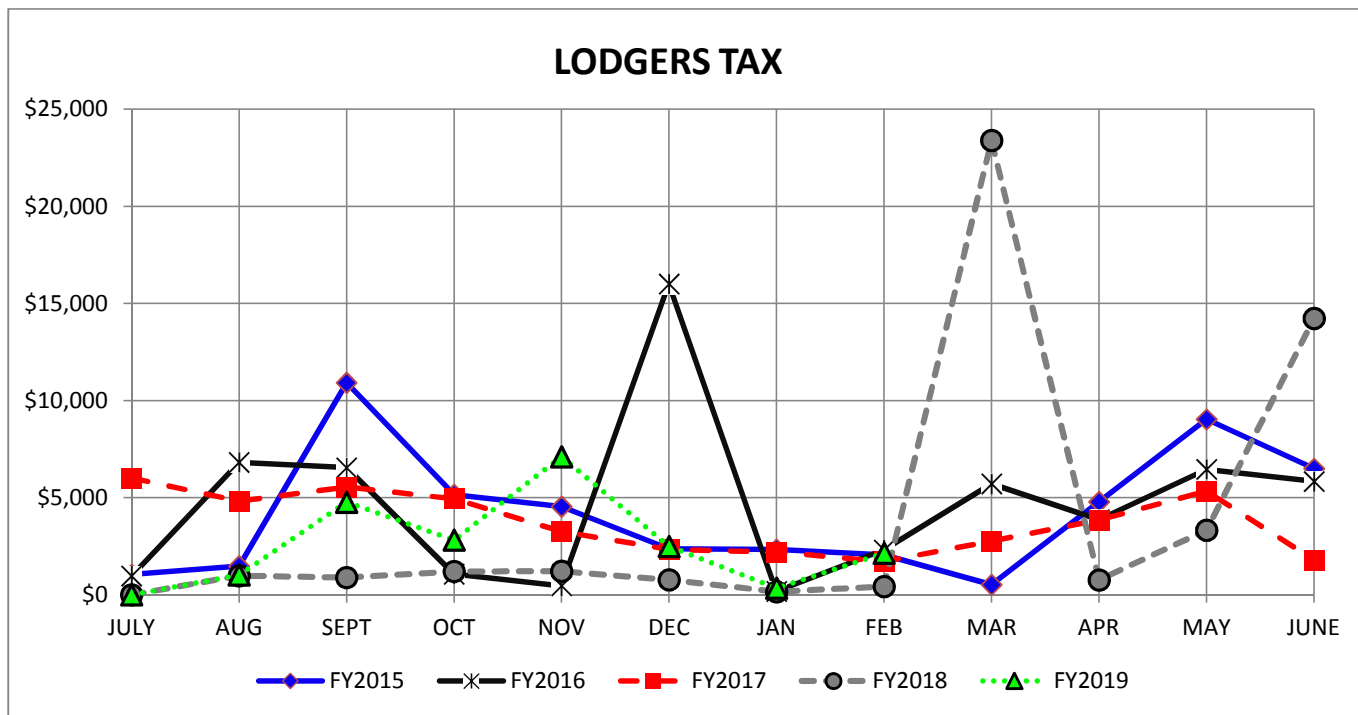
GROSS RECEIPTS MONTHLY DISTRIBUTION: ACCOMMODATION & FOOD



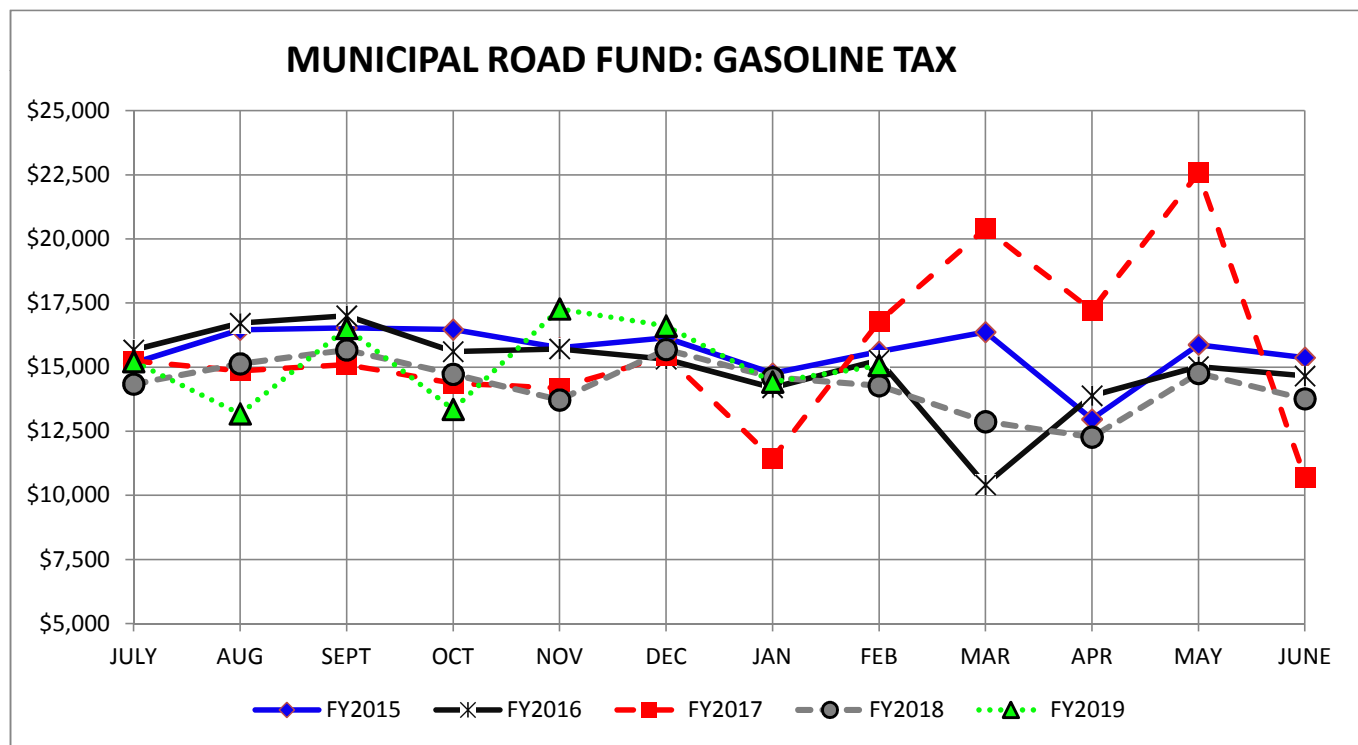
GROSS RECEIPTS MONTHLY DISTRIBUTION: HEALTH CARE AND MEDICAL DISTRIBUTION
