MEMBERS ABSENT: None



**A. Aztec Municipal Golf Course Financials**


Josh Ray, City Manager reviewed the revenues, expenditures, profits, and losses with Commission on the Aztec Municipal Golf Course Financials for FY15 and FY16. For FY15 total loss was \$28,060 and for FY16 total loss was \$121,509. There was discussion on options for the Golf Course 1) Close it 2) Keep it and try to maintain it 3) Do an election in the City to vote for a tax increase 4) Sublet the course 5) Recruit and let someone take over it. Citizens voiced their opinions on the operations and options of the course during the workshop. Commissioner McClure mentioned that at this time the City cannot afford to keep the Golf Course due to the economy. Josh mentioned that the way the numbers are presented the City can only subsidize up to \$40,000 for the year. Mayor Pro-Tem Sipe and Commissioner Randall mentioned that they have more citizens in favor of the course than not. The City is in a 2 year lease and pay \$2,000 a month to the owner of the golf course. The City must give 90 days' notice if they want to terminate their two year lease with the owners of the golf course.


