
A. Municipal Judge Compensation

City Manager Steve Mueller explained that the compensation for the Municipal Judge has not been reexamined since 2003 and in comparison with the rest of the State we are due for an adjustment. This adjustment will not come into effect until after the next election cycle. Judge Carlton Gray reviewed the comparisons of Municipalities of similar sizes to Aztec with Commission. He explained that other judges in the state do not receive the benefit packages like he does but he will qualify for insurance. Compensation for the Judge is set by City ordinance. Commission felt like this is something that will make it current with standard practices throughout the state.


