XI. COMMISSIONER, CITY MANAGER, DEPARTMENT REPORTS

Commissioner Randall gave a shout out to Jeff Blackburn and everyone for their work on the Riverbank stabilization grant project.

Commissioner Lewis attended the San Juan Water Commission Meeting last week. It was interesting, the drought report stated that it snowed a lot but it was late and melted very quickly, they are hoping we have a good monsoon season.

Mayor Pro-Tem Fry mentioned she attended 2 meetings for NWNM seniors and that organization is in the process of being dissolved and the activities will be assumed by the City of Farmington starting on July 1st, 2020. They are waiting for response to the RFP to know what the funding will be and if it will support some of the positions that are held at the different centers. She has been working with the Chamber on the Piano Project and welcoming new businesses on Main Street. She mentioned several businesses downtown and encouraged everyone to get downtown to see them. She encouraged every Commissioner to become a member of the Chamber.


Mayor Snover mentioned he had an ECHO board meeting last week. They have allowed some relaxation on some restrictions with the food boxes. He thanked the folks at ECHO for taking the lead on that and making sure people are fed. He also thanked all the volunteers for non-profit organizations for filling in the gaps. He thanked City workers for all the hard work put in recently with reduced staff because of uncertain budget. He appreciated all the hard work and we have a good group of people to lead us through this from the City Manager on down to the newest employee, we can't thank them enough. He mentioned that we need to be mindful of all the things going on in our country: pandemic, protests around the world around racial equality and equitable society, LGBTQ pride month takes on a more special meaning for him this year because it's symbolic of marginalized societies.


XIII. ADJOURNMENT

Mayor Snover moved to adjourn the meeting at 6:20 pm SECONDED by Commissioner Lewis


