In 2020 they were only able to have a couple of races due to the Governor's COVID-19 restrictions and this impacted them financially. The \$5,000 they were awarded went to trophies and EMS standby. He has spent \$18,000 personally for equipment. They are trying to grow the track and participation. The track is benefiting the outdoor recreation industry. Commissioner Lewis mentioned that he attended the Water Commission last week and they are still looking at doing a diversion release and there are a lot of people on board.

Commissioner Padilla mentioned that he had met with the Community Garden people this week and he mentioned that Mayor Pro-Tem has done a great job with this project.

Mayor Pro-Tem Fry mentioned that she attended an on-site meeting for the Community Garden to tie up some loose ends, they are just waiting on the legality and a contract. She attended a Chamber meeting and created a Piano Committee and they will be setting up a summer schedule.

Mayor Snover thanked Mayor Pro-Tem for spearheading the Piano Project and the Community Garden. Last week he had a meeting with the City Managers and a couple of members of 4CED to discuss ongoing membership and he has asked for a workshop on this the first part of April. Last week they had a call with the newly elected Congresswoman about the needs of the City so we are hoping to get some funding out of the Covid relief package.
