20 **A. Discussion on Public Courtyard (Randy Hodge)**

22 Mayor Snover opened the workshop and turned it over to Interim City  
23 Manager Ken George. Ken explained that last summer we allowed Randy Hodge  
24 with Rubias to use part of the court yard for his business because of COVID. It  
25 worked out wonderfully for Randy and the Community. Randy approached the  
26 City a month ago to ask if he could continue to use the plaza as he did last  
27 summer. Ken thought it would be best to talk about the courtyard as a piece of  
28 public property and get an idea of how the public and commission feel about how  
29 we move forward with the courtyard and it's use.

- 31 • Received mostly positive comments
- 32 • Some felt that an opportunity should have been given to all
- 33 • Downtown looks the best they have seen in the last 5 years
- 34 • Community Development has received a call from another interested party  
35 to use the plaza to assist her business
- 36 • Randy Hodge with Rubias mentioned that last week the State extended  
37 the outdoor liquor license for another 6 months, so he would like to use  
38 the plaza for the 6 months at least.
- 39 • The piano project is interested in hosting more events and would like to  
40 collaborate like they did last year
- 41 • Want to make sure that is able to accommodate who might have interest  
42 in hosting an event
- 43 • Chamber would like to have different events with different groups
- 44 • Randy would be happy to work with anyone on events
- 45 • Need to talk about more of the details and see that it's amendable to co-  
46 operative use

- The plaza is listed under park reservations right now and there are fees that are established in the fee schedule that need to be collected how will this be handled
- A lot of things happening in the background like insurance that will need to be determined
- These are more of a long term issue and Randy just needs to know about the next 6 months
- Could also use Minium Park to set others up for an event


Ken and Steven will talk with staff and get something worked out to bring to Commission at the next meeting
