### **COMMISSIONER. CITY MANAGER. DEPARTMENT REPORT**

Commissioner Randall informed the commission that Riverside Pond has been restocked and noted that he has noticed there has been less trash dumping in the parks

Mayor Pro Tem would like departments to start submitting monthly reports again but would like just a brief update on their departments He informed the commission about an MPO open house at the Farmington Civic Center on March 5 from 5-6 pm Mayor Pro-Tem requested that a closed session be added to the agenda on March 25 to discuss the city manager's contract

Mayor Padilla requested the numbers for completing the Reservoir I from the city manager Jeff said he would get them to the commission

Community Development Director Andrew DiCamillo provided the commission with an update on his meeting with the Main Street group and the organization of the Main Street Board He also mentioned that he will be presenting two resolutions to the commission one related to Main Street and another to rename the Economic Fund to the MRA Fund

The commission asked the City Attorney for her opinion on the matter and she stated that it is an administrative issue that should be handled between the City Manager and the Electric Director.

Police Chief Joe Gonzales had updates for the commission.




