- 5. Vendor has received certification from the State Purchasing Agent for Resident/Contractors Certification. Bidder has been issued the above Certification # and is therefore eligible for the 5% preference credit. <u>In-state</u> certification approval is required at the time of the quote opening to be eligible for in-state preference.
- 6. RESIDENT VETERANS PREFERENCE: In accordance with Sections 13-1-21 and 13-1-22 NMSA 1978 and effective July 1, 2012, a new resident veteran's business preference has been implemented. The Taxation and Revenue Department (TRD) will be issuing a three (3) year certificate to each qualified business. Businesses are required to reapply to TRD every three (3) years with the proper documentation to renew their certificate. Attached is one form to be completed and returned with your quote if your firm will qualify for this preference. The veteran's preference will not be extended without the certificate from TRD and the attached Resident Veterans Preference Certification (next page).

GENERAL

The valve exerciser shall be mounted on a trailer for convenient loading and unloading. The unit is required to be operated by a single worker without assistance. Price shall be quoted for delivery to the Aztec Public Works Dept, 610 Western Dr, Aztec, NM 87410. Unit shall be capable of extending a minimum of 12 feet from the trailer to operate water valves and fire hydrants.

TRAILER

Length – 12.0 feet maximum with all equipment mounted

Width – 6.5 feet maximum with all equipment mounted

Height – 5.0 feet maximum with all equipment mounted

GVW - Not to exceed 1800 lbs.

Tongue Weight – Not to exceed 150 lbs.

Trailer Lights - LED

Electrical Connector – RV plug with standard connections

Equipped with Tool Box

Frame constructed of high carbon structural steel Trailer bed constructed of 7 ga. steel minimum Powder coated frame, bed and fenders 2" hitch size for rated tongue weight Axel rated for weight with 13 inch wheels

Alignment – Self-leveling and swiveling head that allows for operation without perfect alignment Valve Key – Telescoping that operates AWWA 2-inch shall be rated for 100 ft-lbs torque. Unit shall be supplied with 2-3 ft key extension attachments

MECHANICAL

Boom – Spring-loaded, locking levers without loose pins. Shall absorb torque of operation without applying torques to operator.

Locking gas spring-balanced boom & head assembly shall required less than 30 lbs of lift from the operator to place on valve.

Must be able to reach above and around obstacles such as parked vehicles and fences.

Control Panel – Analog torque gauge, LED digital reversible and resettable counter with daylight screen.

Drive – Unit shall be direct drive without mechanical gear reduction that allows for a direct connection to the wrench for a comfortable working height for various sizes of workers.

Power Pack – Engine shall be a minimum of 14 hp.

LED LIGHT BAR PREPARATION

A mounting bar for a 4-foot long Programmable LED light bar shall be designed into the trailer construction. The light bar mounting shall be approximately 6'-6" above pavement height. Additionally, a cigarette lighter receptacle shall be wired into the switch circuit to be used to energize the light bar.

DELIVERY AND TRAINING

 Bids shall include delivery to Aztec Public Works Dept, 610 Western Dr, Aztec, NM 87410. 2. Bids shall include 4 hours of intense training by a factory representative familiar with the complete operations of the unit.

WARRANTY AND SUPPORT

Bids shall include a full 2-year warranty for parts and service for the trailer, valve exerciser unit and arrow board with back-up and support to answer questions relating to operations and troubleshooting problems with the units. The boom shall have a lifetime warranty.

SUPPORTING DOCUMENTS

Supporting documents including catalog cuts, photographs and specifications shall accompany all bids.

PAY ITEMS

1. Valve Exerciser: The equipment shall be paid for at the contract LUMP SUM amount for the item "Valve Exerciser". Payment will include furnishing, transporting a trailermounted water valve exerciser with LED light bar according to the specifications to the Aztec Public Works Dept. at 610 Western Drive, Aztec, NM, 87410 and 4 hours of instruction by a factory representative to train Aztec City Staff in the proper operation of the equipment.
