Good Afternoon Kathy and Team,

We do have contracts with both Baker Supply (utility sales) and Rust Automation (flow/industrial) for the State of NM. How we discern the two are by the following:

Baker is authorized as our sole source for any and all meters that a City/Utility might use for billing purposes to include our utility software platforms and AMI/AMR solutions. With regards to the meters, these encompass typical small/residential meters as well as large meter applications the City/utility might use that are used for producing a bill and/or generating revenue for the utility. These large meters can include ultrasonic, positive displacement, turbine, compounds, and in some cases mag meters.

Rust Automation is our flow instrumentation distribution partner that sells our industrial/commercial meters and applications. As an example, some overlap with the meters can happen. These could also be mag meters but utilized for waste water applications.
