- A. Intent to Adopt Ordinance 2021-514 Amending Chapter 16, Division 3, Section 16-211 Solid Waste Rates

Delain explained that the admin. Fees are currently at 2.43% and they would not be increasing. The only thing increasing is the CPI that is listed in the Waste Management contract. Dan Darnell with Waste Management explained that they are losing money with the Covid pandemic and everything that is going on as well and the only thing they are asking for is the 3% CPI that is listed in the agreement.


XI. ADJOURNMENT
