The City Manager reminded the Commission about the upcoming tour of the Aztec Arterial project scheduled for Thursday at 3:00 p.m. He also presented them with the latest GRT report.

Library Director Angela Watkins gave the Commission a slideshow highlighting activities at the library.

Electric Director John Wheeler asked the Commission for guidance on which projects they would like his department to prioritize and would like to schedule another workshop. He also reported that the Hartman Park lighting project is set to begin on May 8th. Additionally, he noted that the settlement agreement with the City of Farmington, prepared by City Attorney Nann Winter, has been received and forwarded to Farmington. Mayor Padilla acknowledged the quick response by the electric crew in resolving the recent power outage and cleanup on Chuska and Mesa Verde. Commissioner King asked John what the expected completion time for the Hartman Park project was, John estimated it would take approximately 6 to 8 weeks.

Fire Chief Andrew Ekhoff recognized members of his department—Katie Kennedy, Heather Ekhoff, Tim Lopez, and himself—who recently received their Emergency Medical Responder (EMR) and Emergency Medical Technician (EMT) certifications.
