**Ordinance 2025-563**  
**An Ordinance Amending Chapter 22 and Chapter 1**

**WHEREAS,** the City of Aztec provides a free RV Station for wastewater disposal; and

**WHEREAS,** the RV Station also provides potable and non-potable water to assist RV users in maintaining their septic system; and

**WHEREAS,** City staff has on numerous occasions observed that non-RV users have been filling water tanks up illegally, such activity should require a bulk water account; and

**WHEREAS,** in review of City Code there are no regulations governing the permissible use of the RV Station nor fines for use violations;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Aztec, New Mexico, that Ordinance 2025-563 creating in Chapter 22, Section 22-257 RC Station regulations and amending Chapter 1, Section 1-12 Mandatory Penalties to included associate fines be adopted as attached.

## **Chapter 22**

#### **ARTICLE V. USE OF PARKS AND RECREATION AREAS**

---

##### **Sec. 22-527. RV Station.**

The self-service RV Station provides a convenient, no-cost way for people to empty their RV tanks and safely dispose of the wastewater. By helping to reduce improper or illegal dumping from RVs, the new facility helps us better protect our local waterways and public health.

1. RV Dump hours of operation are from sunrise to sunset. The City reserves the right to change the hours of operation without prior notification.
2. The RV Station is only for Recreational Vehicle domestic water and wastewater only. Any use of the domestic water services or wastewater dumping by any non-RV vehicles or individuals is strictly prohibited.
3. The Discharge of any other wastes, chemicals or other substances is prohibited.
4. The taking of non-potable and/or potable water for other purposes is prohibited
5. Recreational vehicles must have a discharge hose to avoid unnecessary spillage problems. The driver is responsible for cleaning up any spills.
6. Users will ensure that children and/or pets are confined to their RV while using the dump station.
7. In consideration for use of the dump station, users agree to defend and indemnify the City from and against all liability, claims and demands, including any third-party claim asserted against the City, on account of any injury, loss, or damage which arise out of, or are in any way related to, your use of the dump station.
8. Violations are subject to Chapter 1-12 Mandatory Penalty and Fees.
