TERMS AND CONDITIONS

Permits will not be processed without all of the required information.

Care and Public Protection

The person making the cut or excavation shall take care to cause the least amount of damage to the adjacent improvements or right-of-way. Work will be performed in such a manner as to minimize inconvenience to the public and permit passage for motorists or pedestrians.

Done Only When Necessary, Supervision

The breaking down, building or replacing of curbing in the streets of the city, as provided in Section 22-21, shall only be done when it is necessary and it shall be under the general supervision of the city engineer or the city manager and the amount of curb to be torn down and replaced shall first be approved by the city engineer or city manager.

General Conditions

1. A sketch plan must be attached showing the area of proposed work, street, driveway, buildings, property line, etc.
2. Curb cut, sidewalk and drive pad shall be constructed in accordance with City Construction Standard D-313.
3. Curb and sidewalk cuts shall extend to the nearest full depth crack or joint. Removal of curb, curb and gutter or sidewalk shall be made so as not to disturb the subbase.
4. **95% compaction testing results must be provided to a City Representative from the Public Works Department.**

Inspection

This permit application must be submitted and approval received prior to any construction. The work must be inspected before concrete/asphalt is poured and a final inspection must be performed when the work is complete. For the required inspections, please contact the City Engineer/Public Works Director at the number listed above.

Permit Posting

An approved copy of this application must be available for inspection at the location when work is performed.

Utility Locating

Applicant is responsible for ensuring all utility locating is performed. Contact New Mexico One-Call at 1-800-321-2537 for utility locating services. Irrigation and sewer laterals are considered private and are not typically marked. Any unmarked lines that are broken are the responsibility of the contractor to repair.

Traffic Control

Vehicular and pedestrian traffic control shall be in accordance with the latest Manual on Uniform Traffic Control Devices (MUTCD).
